HANDLING AND APPLICATION

Preparation of GT-SU Applicator Gun and Cartridge

- 1. GT-SU plunger rods should be fully retracted. To release rods, hold gun by back handle, press thumb lever and pull back on knob.
- 2. Prepare cartridge for loading by removing cover from nozzle end of cartridge and snapping off end cap.
- 3. Load cartridge into gun. Make sure tab at front of cartridge is properly inserted in slot at front of gun. Prior to attaching static mixer nozzle, dispense a small amount of product to be sure both sides flow evenly. To stop dispensing, release pressure by pressing thumb lever.
- 4. Install static mixer. Dispense a short bead of material until color is uniform. Dispose of this bead. Product is now ready for application.
- 5. When application is complete, leave mixer nozzle installed on cartridge. Use a new nozzle for next application.
- 6. Never attempt to force material through a blocked cartridge opening or used nozzle.

APPLICATION

- 7. Black Jack has tremendous adhesion and sealing capabilities and may be applied to both bare metal or primed surfaces. Standard collision repair procedures generally suggest priming bare metal with a catalyzed 2-part epoxy primer **Crest Vers-E-Prime (Stock No. BVEP, BVEPA)** prior to sealing, for optimum results. Aerosols and acid-etch primers are not recommended.
- 8. Make sure area to be sealed is clean and dry.
- 9. Apply Black Jack in a continuous, even bead. To avoid air bubbles, keep mixer nozzle immersed in bead as sealer is applied. Sealer may be tooled easily if desired.
- 10. Do not add solvent when tooling Black Jack.
- 11. Black Jack has a 10 minute working time and may be sanded/painted in 30 minutes.

STORAGE

For future use of the adhesive, after removing from the gun, either leave the mixing tip on or replace the original plug, removed in Step 2. Store the partially used cartridge on its side for future uses
